Key Concerns Raised in 2002 ICCPR Review

- Restrictions in practice of the legal right of detainees to access to counsel, medical treatment and family members
- Susceptibility of the judiciary to political pressure
- Lack of an independent body with power to receive and investigate complaints of human rights violations
- Restrictions on freedom of religion and harassment and detention of religious leaders
- Limitations on the right to freedom of expression in the media
- Obstacles imposed on the registration and free operation of nongovernmental human rights organisations and political parties
- Restrictions on public meetings and demonstrations
