

OPEN CALL FOR EXPERT/S TO DEVELOP A WEBSITE ON CIVIC ENGAGEMENT AND ELECTIONS IN ALBANIA

2. TERMS OF REFERENCE

2.1 The contacting authority

Civil Rights Defenders (CRD) is an international human rights organisation that defends people's civil and political rights on four continents. The organisation has worked with different human rights projects in the Western Balkans since 1995 and its overall goal is to improve people's access to justice through greater respect for their civil and political rights. Civil Rights Defenders has established its presence in Albania in 2013. Since then, the main focus of the country programme has been on the following areas: Rule of law, access to justice, freedom of expression and media freedoms and anti - discrimination.

2.2 The project

The project "I participate! My voice, my vote counts" is funded by the European Instrument for Democracy and Human Rights (EIDHR) and is implemented in Albania by the Albanian Helsinki Committee, Civil Rights Defenders, and Institute for Political Studies¹. This project aims to strengthen civil society's capacity to promote, advocate and support democratic processes, integrity of elections and political transparency and increase citizens' participation in political processes.

Partner organisations in the project:

Albanian Helsinki Committee (AHC) is the first non-profit organization established in the country in December 1990. Its mission is to promote and protect human rights and freedoms and strengthen of the rule of law in the country. AHC remains one of the most prominent organization

for the protection and promotion of human rights in Albania, aiming at increasing the accountability, transparency, public participation and civic engagement in the decision-making processes of public authorities, giving priority at the areas such as education, health, housing, social services and the observation of the rights and freedoms of citizens in general, etc.

The Institute of Political Studies (ISP) was established in 2006, and since then has been focused on monitoring democratic processes and constitutional and independent institutions in Albania, on issues of political representation, electoral standards, integration and inter-Albanian issues. For several years the ISP has monitored the Albanian Parliament activity, political parties, electoral processes, EU negotiations and important reforms such as territorial reform, transparency programs with the right to information and judicial reform.

2.3 The product/the website

In order to educate and engage citizens to participate in political processes, within this project we will develop a website containing information and resources on those processes. The website will be developed in the light of the parliamentary elections in Albania set to take place on **25 April 2021**. The website shall go live 2 months before the election date and will benefit Albanian citizens and other stakeholders in the country. Therefore, the content will be in Albanian.

The purpose of the website is to serve as a learning platform for citizens to find out how can they be involved in democratic processes on a local and national level, what their rights are, what are the obligations of duty bearers as well as what are the legally prescribed mechanisms for their involvement in decision making processes and elections. Moreover, through the website citizens will learn about ways through which they can contribute to free are and fair elections and how to ensure their voting rights are not violated. Overall, the website will contain voter education materials; the opportunity to report election irregularities and infringements of voters' rights, project outputs and activities; as well as reports and findings coming from civil society and media, serving as a platform for them and reflecting freely their perspective. The relevant educational and informative materials will be prepared and provided by the Project Team.

2.4 Eligibility of applicants

The application for this call is open to all **respective legal entities and individual professionals** / **teams of professionals** that meet all the requirements listed in point 2.6 of this call and can fulfill the following responsibilities as per point 2.5 of this call. The nationality of the applicant/s is not a requirement, as long as the language criteria are met.

2.5 Responsibilities of the expert/s

• Establish, design, maintain and update the website.



- Support the entire lifecycle of the website **for the duration of the project**² (including concept, design, test, release, uploading materials³ and providing technical support).
- Facilitate the obtaining of domain, hosting and other necessary processes for the website
- Be able to deliver within deadlines, having in consideration the elections date 25 April 2021.
- Apply tests to identify malfunctions and optimize user experience.

• Liaise regularly with the project coordinator/project team and participate in meetings when needed throughout the implementation period.

• Contribute to planning and suggesting new features/solutions.

• Ensure the compliance of products with the applicable human rights and data protection legislation.

• Compile a final report about website containing figures with regards to the use, number of views and interactions.

2.6 Qualifications and experience of the expert/s

Mandatory:

- At least 3 years of proven work experience in the field
- Examples of previously developed and released websites
- Excellent analytical skills with a good problem-solving attitude
- Excellent communication skills and ability to perform in a team environment of diverse professional backgrounds
- Ability to perform in respect of deadlines

• Excellent command of English and Albanian language is needed. The nationality of the applicant is not a requirement.

Preferable

- Degree in Computer Science or relevant field
- Previous work experience with the NGO sector will be considered an asset.

• Previous relevant experience in the areas of civic engagement and participation in political processes will be considered an asset.

2.7 Grounds for exclusion

Applicants will be rejected if:

• They fail to provide the complete set of documents within the deadline

• They are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;

• They have been convicted of an offence concerning their professional conduct by a judgment which has the force of res judicata;

• They have been guilty of grave professional misconduct proven by any legal means which the Contracting Authority can justify;

• They have not fulfilled obligations relating to the payment of social security contributions or the payment of taxes in accordance with the legal provisions of the country in which they are established or with those of the country of the Contracting Authority or those of the country where the contract is to be performed;

• They have been the subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organization or any other illegal activity.

• They are subject to a conflict of interest. The applicant must not be affected by any conflict of interest and must have no equivalent relation in that respect with other tenderers or parties involved in the project. Any attempt by an applicant to obtain confidential information, enter into unlawful agreements with competitors or influence the evaluation committee or the contracting authority during the process of examining, clarifying, evaluating and comparing tenders will lead to the rejection of the application.

• They fail to comply with the applicable human rights and data protection legislation.

3. THE SELECTION PROCESS

The selection of the most favorable applicant will be internal, and the decision will be made by an evaluation committee of 3 members based on the following evaluation grid. Shortlisted applicants may be invited for an interview to discuss further details should this be necessary. The Contracting Authority reserves the right not to select any offer and/or to repeat the call.

6. A timeline of activities, in line with the proposed timeline of the call and enabling the website to be available at least 2 months before the election date, 25 April 2012.

7. A signed declaration/s by the applicant/s or representative of the legal entity (using the template in Annex I)

8. A completed Legal Entity File for individual/private entities, containing the contact information of the applicant for this call. (Using the template in Annex II)
