After the first draw Club "Vladimir Bayer" Zagreb was selected for the leader of group A, Club "Zoran Kompanjet", Rijeka for the leader of group B, club "Henrik Steska", Ljubljana for the leader of group C and club "Radomir Lukić" Novi Sad for the leader of group D.

“Džemal Bijedić”, Mostar 18 points + 30 (half of points in written briefs) = 48

“Discretio”, Mostar 19 points + 30.5 (half of points in written briefs) = 49.5

According to this, club “Iustiniana Prima” Skopje was qualified for the semi-final, while draw was organized for the teams “ABEA” (Banjaluka) and “Discretio” (Mostar). According to draw, club “Discretio” Mostar become semi-finalist.
